Introduction

This document informs you regarding the collection, use and disclosure of personal information we receive from users of the site and our services as a digital HR data analysis and interpretation business for people professionals.

We are fully GDPR, DPA 2018 and UK-GDPR 2020 compliant according to UK and EU law and have established processes in place to meet these legal requirements.

Information collection and use

Humdex Ltd. Does not collect client personal data through its direct activities as a digital HR data analysis and interpretation business. Any information supplied to them by a client, necessary for the execution of solicited services, must be anonymised prior to receipt by Humdex. Non anonymised data is not accepted or processed by Humdex.
